With the entry into force of Technical Regulation TR ZU 032/2013 on the safety of equipment operating under pressure, Eurasian Customs Union legislation has been brought into line with the pressure equipment requirements of the current European standards and regulations.

For example, exporting manufacturers may now make use of the EN 13445 series of standards in the design and manufacture of pressure vessels. For the first time, categorisation of the vessels (Categories I, II, III, IV) and grouping of operating media (Groups 1, 2) are included under the Regulation.

Even after this change, however, approvals issued for Europe will not be directly recognised by the countries of the Customs Union. Nevertheless, individual evidences, such as results of non-destructive tests, material certificates, evidences of suitability and also specialist welding company certificates – as are necessary for approval in the EU – can also be used for approval on the Customs Union market. This means that the new Technical Regulation makes the process easier for European manufacturers and exporters, although some requirements continue to be country-specific.

Following successful completion of the approval process, pressure vessels are provided with a mark confirming access to the Customs Union.
