The Eurasian Economic Union (EAEU) has its own rules when it comes to product certification; these rules are now becoming more and more like those which apply in Europe. The product certification is a fundamental prerequisite for every export transaction. Currently, the newly-introduced Technical Regulations (TR) apply in the EAEU states Russia, Kazakhstan, Armenia, Kyrgyzstan and Belarus and define minimum safety requirements for products.

TÜV NORD CERT informs companies about the documents they need for exporting a particular product and helps with procurement of the necessary certificates and approvals. In addition, TÜV NORD CERT know-how is available in the form of in-house training and workshops.

Target groups for service

This service is intended for companies from Germany and other countries who wish to export plant, machinery and equipment to the EAEU (Russia, Kazakhstan, Belarus, Armenia, Kyrgyzstan) or to Ukraine. Documents that are required for further products, such as clothing, jewellery, toys, cosmetics, food, construction materials etc. can generally also be obtained.

In concrete terms, TÜV NORD CERT can obtain the following documents:

- TR Certificates of Conformity / TR Declarations of Conformity (EAEU)
- TR Certificates of Conformity (Ukraine)
- State registration in the hygiene sector
- Registration of medical devices
- Registration of measuring equipment
- Technical certificates (construction products)
- Industrial safety assessment
- Machinery and equipment passports (e.g. pressure equipment)

If companies supply to Eastern Europe, they often do not know which certificates are needed and what conditions have to be fulfilled. Preconditions for service

In order to apply for issue of the necessary documents by the Eastern European states, the following documents must first be submitted:

- Contracts and delivery specifications (for certificates for supply of one-off items)
- Precise designation of goods and customs tariff numbers (HS-code)
- Risk analysis (in Russian)
- Product documentation such as operating instructions, data sheets, safety data sheets, brochures, catalogues, machinery and equipment passports (for series production, preferably in Russian)
- European certificates and evidences (e.g. ISO 9001 certificates, EC Declarations of Conformity, Test and Assessment Reports, Material Certificates)
- Depending on the particular product, certification procedure and country, test samples may also be required.
- Occasionally audits have to be carried out by the Russian side at the manufacturer's facilities. TÜV NORD CERT can then accompany the Russian auditors.
