The new IFS HPC version 3

IFS – International Featured Standards is pleased to announce the publication of the new IFS HPC version 3. IFS HPC is a worldwide acknowledged standard for assessing manufacturers of household and personal care products focusing on quality, safety, and production processes. The standard is applicable to private labels, manufacturers’ brands and non-branded products used by other organisations.

The new version of the standard provides a better approach to the detailed assessment of a company’s product safety and quality management, including customer specifications. Its particular focus on assessing relevant and topical issues for the HPC industry, like hazard analysis, risk assessment, allergen risk mitigation, product safety culture, and product specifications, clearly demonstrates the objectives of the new IFS HPC Standard. The business partners trust this solid and coherent approach.



IFS HPC Version 3

IFS HPC version 3 at a glance

The most relevant changes and improvements are:

- > The audit approach is more solid and coherent.
- > You now have the option of having the audit performed unannounced. This way you can show your customers that you constantly meet the standard requirements.
- > The wording of the requirements is more consistent and prescriptive for better comprehensibility.
- > The scoring system has been updated.
- > Product safety culture has been incorporated into the requirements.



Timelines



IFS HPC version 3 audits are possible from **1st June 2023** and become mandatory for all certified companies as of 1st September. In general, the applicability of IFS HPC version 2 ends **31st August 2023**.

In the IFS HPC version 3 doctrine that we will publish before June 2023, we will explain the exceptional situations in which the application of IFS HPC version 2 is possible after this date.

What's new in the checklist

Voluntary Unannounced Audits

With IFS HPC version 3, you will have the option to have the audit performed unannounced. This option can apply to recertification and initial assessments.

Unannounced audits **increase credibility in the audit process**. They demonstrate compliance and assure your stakeholders that you are operating at the same level of safety and complying with IFS Requirements each day.

Scoring

In IFS HPC version 3 the scoring system has been updated.

We are **working on a new scoring brochure** that we will publish before the first HPC version 3 audits will take place.

Product Safety Culture

Product safety culture is addressed throughout the standard. It is also **explicitly included in three requirements**. For more information, see our Product Safety Culture fact sheet. It is available on the HPC Standard page of the IFS Website.
